RESOLUTION EXTENDING THE DEADLINE OF THE TIME OF PAYMENT OF BUSINESS TAX FOR CY 2020 FROM JANUARY 20, 2020 TO FEBRUARY 20, 2020.

WHEREAS, poor internet signal and the initialization of correct data in the newly introduced Electronic Business Permit and Licensing System (eBPLS) cause a delay in the processing of business permit;

WHEREAS, the renewal of business permit is scheduled within the first twenty (20) days of January each year;

WHEREAS, Section 2C.03 of the Revenue Code of the Municipality of Calamba, Misamis Occidental provides:

Time of Payment. The tax shall be paid once within the first twenty (20) days of January or in quarterly installments within the first twenty (20) days of January, April, July and October each year. The Sangguniang Bayan may, for a justifiable reason or cause, extend the time for payment of such taxes without surcharges or penalties, but only for a period no exceeding six (6) months.

WHEREAS, the 21st Sangguniang Bayan finds the validity of the above-mentioned reason, hence this resolution.

WHEREAS, on motion of Hon. Emmanuel M. Cale and duly seconded by all the members present;

NOW THEREFORE ON JOINT SPONSORSHIP, Be it resolved by the Sangguniang Bayan of Calamba, Misamis Occidental as it is hereby resolved to extend the Deadline of the Time of Payment of Business Tax for CY 2020 from January 20, 2020 to February 20, 2020.

RESOLVED FINALLY that copy of this resolution be furnished to Mr. Remwel L. Jaim, Municipal Treasurer for information, guidance and appropriate action.
