ORDINANCE NO. 18-s.2020

AN **ORDINANCE** MANDATING STRICT **OBSERVANCE** IMPLEMENTATION OF THE GENERAL COMMUNITY QUARANTINE IN THE MUNICIPALITY OF CALAMBA, MISAMIS OCCIDENTAL.

Whereas, by virtue of the exercise of police power under Section 16 & 177 of the Local Government Code of 1991, it is the duty of the Municipal Government of Calamba, Misamis Occidental to adopt an ordinance necessary to fully provide and protect the health, safety, comfort, convenience to the general welfare of the community and its inhabitants.

Whereas, the LGU of Calamba manifest its earnest desire to strictly implement the mandates with the end-in-view of preventing and or containing the transmission of the Corona Virus in the Municipality of Calamba:

Whereas, with COVID-19, the goal of social distancing is to slow down the outbreak in order to reduce the chance of infection among high risk population to reduce the burden on health care system of workers;

Whereas, all the guidelines set by DOH, IATF and DOTr and its local counterpart to establish response measures and activities to prevent the spread of infection or epidemics, and prevent re-occurrence;

Whereas, Omnibus Public Transport Protocols/Guidelines set by the DOTr of the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-EID) covering road transport, aviation, maritime and railways sector.

Section. 1. TITLE. This Ordinance shall be known as "An Ordinance Mandating Strict Observance of the Wearing of Face Shield and Face Mask and Implementation of Capacity on Road Transport Vehicles".

Section 2. SCOPE AND APPLICATION This ordinance shall apply to every natural person whether resident, non-resident or even transients with in the territorial jurisdiction of the Municipality of Calamba, Misamis Occidental.

Section 3. DEFINITION ... TERMS. When used in this ordinance use following shall refer to:

- a. Natural Person refer to resident, non-resident of even transient, found within the territorial jurisdiction of the Municipality of Calamba, Misamis Occidental.
- b. Tricycles a 3-wheeled vehicle propelled by pedal or a motor use as public conveyance.
- c. Motorcycles a vehicle with 2- in line wheels used as public/private means or transportation especially in a remote barangays
- d. Frontliners a person that is a part of leading position
- e. Emergency exemption granted in violation of the law, like responding to emergency call.
- f. Indispensable travel Travel authority only for person crossing/provincial/regional boarders, travel pass inorder to pass through control point established along boundaries.

Section 4. GUIDELINES IN THE IMPLEMENTATION OF BACK-RIDING ON MOTORCYCLES AND TRICYCLES.

- a. A safety barriers/shield whose design is duly approved by the IATF National Task Force COVID-19 must be placed between the driver and the passenger;
- b. Motorcycles Back-Riding shall be allowed for couples living in the same household and family members of the household;
- c. Valid ID's shall be presented as proof, that said persons are living together or married to one another, or as live-in-partners living in the same household.
- d. Said persons riding on motorcycle shall observe the minimum public health standards set forth by the DOH such as the wearing of facemask and face shield.
- e. Tricycles shall be allowed one (1) passenger only except for members of the household. Wearing of face mask and face shield is mandatory to all drivers and passengers.

Section 5. EXEMPTIONS. The following are exempted on barrier and capacity on motorcycle and tricycle:

- 1. Frontliners
- 2. During Emergency
- Indispensable Travel

Section 6. PENALTIES. Driver/Passenger found violating any of the provisions above, shall be fined to the following;

First Offense - a fine of P1,000.00 and/or imprisonment 10-30 days at the discretion of the court.

2nd Offense - a fine of P1,500.00 and/or imprisonment 10-30 days at the discretion of the court.

3rd Offense - a fine of P2,500.00 and/or imprisonment 10-30 days at the discretion of the court.

Section 7. WHEN AND WHERE TO PAY THE ADMINISTRATIVE FINE. Within seven (7) working days from receipt of the citation ticket the violator shall pay the penalty in the Office of the Municipal Treasurer.

Section 8. FAILURE TO PAY THE PENALTY. If the violator fails or refuses to pay the penalty within seven (7) working days from receipt of the citation ticket, the violators will face an appropriate case for violation of this Ordinance before the proper Court.

Section 9. DURATION OF THE IMPLEMENTATION. This ordinance shall be effective during the entire period of the Community Quarantine.

Section 11. SEPARABILITY CLAUSE. Any part or provision of this Ordinance is declared invalid or unconstitutional by a competent court of law shall not affect the remaining operative part or provision thereof.

Section 12. This Ordinance shall take effect upon approval.
